B.Sc.(Ag.Env.Sc.); **Specialization in Animal Production** (24 cr.) – program description, required courses deleted, a required course added, required credits decreased, complementary-course section added, complementary courses added, complementary credits increased. *Chair's comments/corrections*: Revise program description to read The B.Sc.(Ag.Env.Sc.); Specialization in Animal Production focuses on the improved efficiency of livestock production ... levels, including animal nutrition, physiology ... this <u>program</u>" – delete last sentence on advising. *Secretary's comments/corrections*: Underline all additions in the proposed column; add following the complementary heading "3 credits from the following:"

B.A.; Faculty Program in Environment; Environment and Development (54 cr.) – program description, course requirement headings revised, a required course note revised, required courses grouped together, complementary courses grouped together, complementary courses deleted, complementary courses added, how complementary courses chosen revised. *Chair's comments/corrections*: Revise program description to read "The B.A.; Faculty Program in Environment; Environment and Development is an introduction to theories, ... and development. The problems and solutions to ... crisis, which include: the natural world, theories behind economic ... organizations; and sustainability and the climate crisis"; consultation for ATOC indicates that ATOC 341 is being added, but it has not been added to the program; provide a short response that addresses how the comments on the consultations were or were not followed; remove consultation to delete AGRI, CANS, and URBP courses from program – these have already been removed; remove the BIOL consultation – the course is already in the program; consultations to remove courses from a program are not required by SCTP.

B.Mus.; Minor in Music Education (18 cr.) – program description, streams removed from complementary courses, lists of complementary courses amalgamated into one group, how complementary courses chosen revised. *Secretary's comments/corrections*: Indicate the overall credits following the complementary courses heading; use strikethrough in the proposed column on "15 credits ..."

B.Mus.; Major in Performance (Orchestral Instruments) (125 cr.) – credit weight increased for a complementary course. *Secretary's comments/corrections*: Indicate program credit weight on page 1 – box 4.0; use strikethrough in existing column only on "2 credits" for MUPG 300; use underlining only on "3 credits" in proposed column; the requirements on page three need to be in both of the existing and proposed columns [do not want any requirements erroneously removed from the eCalendar].

B.Mus.; Major in Performance Voice (123 cr.) – credit weight increased for a complementary course. *Secretary's comments/corrections*: Indicate program credit weight on page 1 – box 4.0; use strikethrough in existing column only on "2" for MUPG 300; use underlining only on "3" in proposed column [using strikethrough on the entire entry means to remove the course from the list, which is not being done; using underlining on the entire entry in proposed column means add the course, which is not being done.

The foundations needed to explore the diverse area of mathematics ... geometric group theory" – delete "etc." – if more examples, then list them, and delete last sentence. *Secretary's comments/corrections*: Correct the program credit weight in box 4.0 to "60-63"; correct the existing description to read what is included in the eCalendar and include it also in the proposed description.

B.Sc.; **Honours in Applied Mathematics** (60-63 cr.) – program description, program prerequisite courses revised to indicate full course number, required-course text revised to indicate full course number, a required course deleted, required credits decreased, complementary courses added, a program note revised, how complementary courses chosen revised, complementary credits increased. *Chair's comments/corrections*: Rewrite the program description, as what is proposed is not appropriate – only the focus/subject of this program needs to be indicated, do not focus on students, or the courses students will take, and remove the entire last sentence – it is advising information. *Secretary's comments/corrections*: Correct the program credit weight in box 4.0 to "60-63"; correct the existing description to read what is at the beginning of the proposed column.

B.Sc.; Honours in Mathematics and Computer Science (72-78 cr.) – program description, a required course deleted, required credits decreased, complementary courses added, a program note revised, how complementary courses chosen revised, complementary credits increased. Secretary's comments/corrections: Correct the program credit weight in box 4.0 to "72-78"; correct the existing description to read what is in the eCalendar and include it at the end of the revised program description.
