**B.A.; Joint Honours - Component in Hispanic Studies** (36 cr.) – program description, a required course deleted, required credits decreased, complementary courses deleted, how complementary courses chosen revised, complementary credits increased. *Chair's comments/corrections:* Rewrite the program description so it focuses only on the subject of this program, remove referral to courses, university education, and delete last sentence. *Secretary's comments/corrections:* Correct how the complementary courses are to be chosen – they do not add up to 30 credits.
