Secretary's comments/corrections: Title abbreviation revised, as there is no need to indicate shortened "Lab"; revise restriction to remove AEMA 100, as it has been retired as of 2011, remove last sentence from restriction and add it to the prerequisite; inform the Department of Mathematics and Statistics that they should revise MATH 112 to include in the restriction: "Not open to students who have taken or are taking AEMA 105"; remove AEMA 101 from the supplementary info, as the course is listed as corequisite;
