Minor and Moderate Revisions

Faculty of Dentistry

D.M.D. (218.5 credits) – a required course added, credit weight decreased for a required course. *Rationale:* Course updates.

Ph.D. in Microbiology and Immunology (0 cr.) – complementary course added, how complementary courses chosen revised, complementary-course note revised. *Rationale:* Updates to courses; the revised note will avoid having to do student adjustments for course substitution; *ES Comments/Corrections:* **If courses that are not currently offered will remain in the program, add a note for MIMM 617, MIMM 618, and MIMM 619;**

M.Sc.(A.) in Occupational Therapy; Non-Thesis (58 cr.) – a required course added. *Rationale:* Updates to courses to provide appropriate tools and skills for students;

M.Mus. in Performance; Jazz Performance (45 cr.) – program prerequisite courses deleted, a complementary course added, how complementary courses chosen revised, complementary credits increases, elective credits deleted.
