#### MCGILL UNIVERSITY SENATE

Report of the Senate Steering Committee 19-20:09

The Senate Steering Committee met on May 5, 2020, in preparation for the Senate meeting of May 13, 2020. This report contains items that are presented to Senate for its consideration and information.

#### 1. APPROVAL OF MINUTES OF SENATE

The minutes of the April 15, 2020 Senate electronic vote and April 21, 2020 virtual meeting were circulated to the Steering Committee, and the Steering Committee provided feedback. It is recommended that they now be considered by Senate for approval.

The motion (submitted by Senator Nystrom) concerned organizing a special Senate meeting to consider the recommendations of the Academic Planning Group for Fall 2020 term. After careful consideration and a thorough discussion, the Committee decided not to submit the motion to Senate. In coming to this decision, the Committee noted that:

Regular governance processes will be respected regarding items requiring consideration by Senate. Items of a governance nature, related to, for example, academic policy, will be submitted to the appropriate Senate Committee (i.e. APC) and to Senate for approval. It is understood that if urgent governance items arise over the summer months, a special meeting of Senate will be scheduled. Conversely, it was noted that the Academic Planning Group's work focuses on operational, not governance matters. The Group reports to the Provost and does not have a mandate to formulate recommendations to Senate.

- The University is committed to informing and engaging the McGill community on the work being done with respect to COVID-19 planning. In this respect, it was mentioned that a town hall on Fall 2020 academic planning was organized by the Office of the Provost and Vice-Principal (Academic).
- An Open Discussion on COVID-19 academic planning has been added to the Senate agenda for the May 13 virtual Senate meeting. The Open Discussion will provide an opportunity to engage Senate in discussion on how to, from a governance perspective, best prepare for the next year.

  Guidelines. (Based on the Guidelines, in such situations, the Committee Chair would
  form and convene an ad hoc sub-committee composed of the Principal and three to five
  members of the Committee, to consider the matter and to advise the Committee
  accordingly.)
- Expressly mentioning that the University Registrar and Executive Director, Enrolment Services, or delegate will serve as a resource person to the Committee.

Honorary Degrees and Convocations Committee Terms of Reference

#### I. MANDATE

The Honorary Degrees and Convocations Committee ("Committee") is a Standing Committee of Senate. Its mandate is to recommend to Senate outstanding individuals for the conferral of McGill honorary degrees, the highest honour that the University can bestow. It shall also advise on convocations matters as required.

Individuals nominated for honorary degrees have lifetime records of outstanding scholarly, scientific or artistic achievement, or of exceptional contributions to the public good through professional or philanthropic activity, that make them worthy candidates and position them to contribute to McGill's reputation and distinction both at home and internationally.

The Committee shall meet in closed session and all matters related to individuals nominated for honorary degrees shall be treated in strict confidence by the Committee.

#### II. SPECIFIC AREAS OF RESPONSIBILITY

The Committee shall:

- 1. Solicit, receive and review nominations for the conferral of honorary degrees from the Faculties, from individual members of the McGill community, from members of Senate, from the McGill Alumni Association and from members of the broader community;
- 2. Select candidates for the conferral of honorary degrees and submit them to Senate for approval;
- 3. Recommend the particular honorary degree that should be awarded to each candidate submitted to Senate for approval;
- 4. Develop guidelines for the selection of candidates for McGill honorary degrees and submit them to Senate for approval;
- 4. Recommend to Senate the revocation of an honorary degree in situations where maintaining the honorary degree would be prejudicial to the University's reputation and/or found to be in contradiction to the University's mission or values.
- 5. Receive, <u>and</u> review <u>and recommend to Senate for approval</u> nominations from the Principal's Advisory Committee for the conferral of the McGill University Medal for Exceptional Academic Achievement (The McGill Medal);

- 6. Receive, review and recommend to Senate for approval nominations from the Adjudication Committee for the Lifetime Achievement Award for Leadership in Learning for the conferral of the Lifetime Achievement Award for Leadership in Learning;
- 7. Approve, on behalf of Senate, dates for convocation ceremonies;
- 6.8. Advise Senate <u>and the appropriate administrative unit of the University</u> as <u>required</u>, <u>appropriate</u> on convocation matters;
- 9. Develop guidelines, as necessary, for the purpose of operationalizing its mandate;
- 7.10. Meet at least twice a year (in closed session).

#### **III. COMPOSITION**

#### Composition:

The Committee shall be composed of 14 members, as follows:

- The Chancellor (Chair of the Committee), ex officio
- The Principal and Vice-Chancellor, ex officio
- The Provost and Vice-Principal (Academic), ex officio
- The Chair of the Board or delegate, exofficio
- The A University Co-Marshal, ex officio
- The President of the McGill Alumni Association or delegate, ex officio
- Six representatives of Senate, to be nominated by the Senate Nominating Committee and appointed by Senate to reflect the breadth of the University
- One graduate student
- One undergraduate student

The Secretary-General (Committee Secretary)shall serve as Secretary and governance advisor to the Committee.

The University Registrar and Executive Director, Enrolment Services, or delegate, shall serve as a resource person.

Annual Report of the Committee on Staff Grievances and Disciplinary Procedures (2018-19)

In accordance with article 10.9 of the *Regulations Relating to the Employment of Academic Staff* (Regulations), "the Committee on Staff Grievances and Disciplinary Procedures shall report annually to Senate and to the Board on the administration of the procedures described here."

A staff member may file a grievance if he or she believes that he or she:

- (i) has been unfairly treated by the University in regard to the interpretation or application of University policy insofar as it relates to his or her academic career and working conditions; or
- (ii) has been subjected to arbitrary, discriminatory, or unreasonable actions taken against him or her by the University, either by act or omission

Attempts are to be made to resolve the grievance before it reaches the Committee on Staff Grievances and Disciplinary Procedures, pursuant to the defined Stages 1 and 2 of the Regulations. Following due process, the Committee determines whether the matter is to be considered an academic evaluation grievance or an administrative grievance.

Based on a review of cases in the last 5 years, there were 12 cases filed, 9 of which were heard by the Committee.

#### **Annual Report on the Policy on Safe Disclosure ("Whistle Blowing")**

#### Introduction

The *Policy on Safe Disclosure* ("Whistle Blowing") was approved by Senate in May 2007 and by the Board of Governors in October 2007, and came into force on October 30, 2007. Following a review of the Policy, Senate approved revisions to the Policy on November 18, 2015. The revisions were then approved by the Board of Governors on November 26, 2015.

As stated in the Policy, those responsible for the administration and management of academic, administrative or service units are responsible for addressing situations of Improper Activity in accordance with good management practices and existing policies, guidelines and procedures. It is the expectation that members of the University community will continue to use existing channels to report Improper Activity and only resort to this Policy if such channels prove ineffective or are inappropriate in the circumstances. Section 8.1 of the Policy provides that the Secretary-General report annually to Senate and the Board of Governors on the application of the Policy. This report is presented to Senate and the Board of Governors in discharge of this obligation for the period January 1, 2018 through December 31, 2018.

The annual report shall respect the privacy of Disclosers and Respondents, as stipulated at various points in the Policy.

#### Report

During the reporting period from January 1, 2019 through December 31, 2019, one confidential disclosure was filed with the Secretary-General in accordance with the Policy. The report was reviewed by the relevant Responsible Officer, who determined that further action was warranted.
