- i. On March 18th, 2019, APC electronically approved a student exchange partnership between the McGill Schulich School of Music and the Central Conservatory of Music (CCoM) in Beijing, China. The CCoM is China's leading conservatory and one of the top music schools in the world. It counts approximately 2,000 students and over 300 academic staff members, and offers undergraduate degrees, graduate degrees and diplomas in Western music and traditional Chinese instruments.
- ii. On March 18th, 2019, APC electronically approved a student exchange partnership between the McGill Faculty of Engineering and INSA Rouen Normandie in France. This French "Grande École" trains engineers at all levels, and it counts eight research laboratories, four of which are also CNRS (Centre National de Recherche Scientifique) research laboratories. Also, the INSA Rouen Normandie provides students with a collaborative research approach, exposing them to high calibre research conducted by leaders in their fields.
