# Report of the Board of Governors to Senate Senate Meeting of May 15, 2019 D18-74

The following report is presented to Senate for information.

Since last reporting to Senate on March 27, 2019, the Board of Governors met on April 11 and April 25, 2019. The Executive Committee of the Board of Governors met on March 28 and May 6, 2019.

### I. APPROVALS

### 1. Decision concerning the Redmen Name

[GD18-41]

The Board of Governors, on the recommendation of the Chair of the Board of Governors, endorsed the Principal's decision that McGill University's men's varsity teams cease to be called the Redmen. The decision came into effect on April 12, 2019.

### 2. Report of the Finance Committee

### 2.1 Proposed McGill University Budget 2019-20

The Board of Governors, on the recommendation of the Finance Committee, approved the proposed 2019-2020 McGill University Budget. The proposed budget was presented to Senate at its April 2019 meeting.

### 3. Report of the Building and Property Committee

### 3.1 Extension for Disposition of Property at Macdonald Campus: Brittain Hall

The Board of Governors, on the recommendation of the Building and Property Committee, approved to extend by 6 months, to October 26, 2019, the timeframe for the sale of Brittain Hall and the land on which it stands to John Abbott College. This extension should allow for John Abbott College to receive authorization for its project planned at the Brittain Hall site.

### 3.2 Leacock Terrace Infrastructure & Amphitheatre

The Board of Governors, on the recommendation of the Building and Property Committee, approved the Leacock Terrace Infrastructure and Amphitheatre at a cost of \$14,346,611, bringing the total budget for this project to \$17,403,511.

### 3.3 Stewart Biology Redevelopment: Phase I West Wing

The Board of Governors, on the recommendation of the Building and Property Committee, approved Lot 3 of 4 of the Redevelopment of the West Wing of the Stewart Biology Building at a cost of \$59,257,101, bringing the total project budget to \$126,164,496.

### 3.4 Southwest-Northeast Smart Energy Grids

The Executive Committee of the Board of Governors, on the recommendation of the Building and Property Committee, approved the Southwest-Northeast Smart Energy Grids Project, at a total project cost of \$8,900,000. This project consists of the deployment of low-temperature heat recovery loops in the buildings of the southwest and northeast quadrants of McGill's downtown campus and is a key component of the 2016-2020 implementation phase of McGill's Energy Management Plan.

### 4.1 Revisions to the Policy against Sexual Violence

The Executive Committee of the Board of Governors, on the recommendation of Senate, approved proposed revisions to the *Policy against Sexual Violence*. The revisions to the Policy were developed through an extensive consultation process led by a working group chaired by the Associate Provost (Equity and Academic Policies). The Executive Committee of the Board of Governors, on the recommendation of Senate, approved proposed revisions to the *Policy on Harassment, Sexual Harassment and discrimination Prohibited by Law.* The Policy was reviewed to reflect concurrent revisions to the *Policy against Sexual Violence*. Also captured by the revisions is an amendment to the name of the Policy from the Policy on Harassment, Sexual Harassment, and Discrimination Prohibited by Law to the *Policy on Harassment and Discrimination Prohibited by Law*. ### 4.3 Report of the Senate Nominating Committee

# 5. Canada Excellence Research Chair in Genomics Medicine Grant [ED18-36] Agreement: Genes to drug targets for next generation therapies

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Research and Innovation) approved the Grant Agreement supporting the establishment of the Canada Excellence Research Chair (CERC) in Genomic Medicine, valued at \$10 million, between McGill University and the Tri-agency Institutional Programs Secretariat (TIPS). This funding will allow the CERC Chairholder to set up a program that will leverage information from large-scale sequencing of the human genome to identify and validate new drug targets and to advance a drug development program at McGill.
