Report of the Board of Governors to Senate Senate Meeting of January 16, 2019 D18-40

The following report is presented to Senate for information.

Since last reporting to Senate on October 24, 2018, the Board of Governors met on December 13, 2018. The Executive Committee of the Board of Governors met on October 29, 2018 and held an electronic vote on December 18, 2018.

Appendix A contains a series of promotions and grants of tenure, which were approved by the Board of Governors or the Executive Committee of the Board of Governors.

Appendix B contains a series of appointments and reappointments to Board standing committees, internal and external non-Board bodies, healthcare bodies, and committees arising out of University Regulations, which have been approved by the Board of Governors or the Executive Committee.

I. APPOINTMENTS

1. Reappointment of the Dean of the Faculty of Education

The Board of Governors, on the recommendation of the Principal and following the advice of the Advisory Committee that had been established to consider the reappointment of the Dean, approved the reappointment of Professor Dilson Rassier as Dean of the Faculty of Education of McGill University for a second five-year term, commencing July 1, 2019 and ending on June 30, 2024.

II. OTHER APPROVALS

1. Report of the Building and Property Committee

1.1 Plan décennal des investissements universitaires 2019-2029

The Executive Committee of the Board of Governors, on the recommendation of the Building and Property Committee, approved the submission of the *Plan décennal des investissements universitaires* (PDIU) 2019-2029 to the *Ministère de l'Économie, de la Science et de l'Innovation* (MESI) and the *Ministère de l'Éducation et de l'Enseignement supérieur* (MEES). The PDIU serves as a guideline to the Government of Quebec of all capital projects the University is considering moving forward with over the next ten years.

1.2 Revision of servitude path to City of Montreal for provision of water at Macdonald Campus

The Executive Committee of the Board of Governors, on the recommendation of the Building and Property Committee, approved an amendment to an agreement of servitude with the City of Montreal for provision of water at Macdonald Campus. The initial agreement of servitude was approved by the Executive Committee of the Board in 2008, and signed by the Vice-Principal (Administration and Finance) in 2011. The City of Montreal discovered that the site contemplated by the originally agreed upon servitude was erroneously designated as property belonging to the University. Revisions to the servitude agreement have been implemented to identify the correct path.

1.3 Extension for Disposal of Property at Macdonald Campus – Brittain Hall

The Executive Committee of the Board of Governors, on the recommendation of the Building and Property Committee, approved to extend by 6 months (to April 26, 2019), the timeframe for the sale of Brittain Hall and the land on which it stands to John Abbott College. The transaction with the Government of was delayed mainly because of a provincial government slowdown precipitated by the 2018 Quebec general election, which was held on October 1. This 6-month extension was necessary to allow sufficient time for the incoming government to name its cabinet, including a new Minister of Higher Education, who could then authorize completion of the transaction.

1.4 Additional Leased Space at 2001 McGill College

The Executive Committee of the Board of Governors, on the recommendation of the Building and Property Committee, approved to exercise an expansion option under the lease with Cominar at 2001 McGill College for an additional 42,200 ft² to house the Faculty of Medicine's School of Population and Global Health. The lease term is for a period of 14 years and 4 months.

2. Funding Agreement for Royal Victoria Hospital Redevelopment Project and Related Contracts

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Administration and Finance), approved the *Convention d'aide financière* (Funding Agreement) between McGill and the Government of Quebec for the University's receipt of a financial contribution of \$37M in support of the next phase of the Royal Victoria Hospital Site Redevelopment project. The Funding Agreement defines what will constitute an eligible and non-eligible project expense, and outlines the Government's and McGill's respective obligations with respect to the financial contribution.

The Board was subsequently informed that the funding agreement has since been executed and remains conditional on the signing of a *protocole d'entente* (Memorandum of Understanding) on the project's governance structure by the University, the *Ministère*

de l'Éducation et de l'Enseignement supérieur (MEES), and the Société québécoise des infrastructures (SQI). The Board also received an updated timeline for the development of the McGill Pavilion on the RVH site and was informed of plans to establish the site master plan by January 2021.

3. CFI Grant Agreement – Eastern Canadian Plant Phenotyping Platform

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Research and Innovation), approved the Canada Foundation for Innovation (CFI) Grant Agreement for the Eastern Canadian Plant Phenotyping Platform (ECP3). This grant agreement is valued at \$27.4M and will establish a new facility to support research on climate change mitigation and technologies that reduce the impact of agriculture on the environment.

4. Competitive Tender for the Provision of Food Services

The Board of Governors, on the recommendation of the Interim Deputy Provost (Student Life and Learning), authorized McGill University to launch a competitive tender process for the provision of food services for the University over a five year period beginning June 1, 2019, with a five year extension option. The Board also authorized the Interim Deputy Provost (Student Life and Learning) to sign the resulting contract and all other documents related to the competitive tender, provided that Legal Services review them.

5. Report from Senate

7.1 Department Name Change

The Board of Governors, on the recommendation of Senate, approved the renaming of the Department of Ophthalmology to Department of Ophthalmology and Visual Sciences.

7.2 Consolidation of Sustainability Policy and Environmental Policy

The Board of Governors, on the recommendation of Senate, approved the revised *Sustainability Policy*, and the repeal of the *Environmental Policy*.

III. INFORMATIONAL ITEMS

1. Update on CAMSR's Activities

At its meeting on October 22, 2018, the Committee to Advise on Matters of Social Responsibility (CAMSR) discussed the motion concerning divestment from the fossil fuel industry that had been approved by Senate, and determined that it would review the issue of divestment from the fossil fuel industry, including the current context and recent developments regarding climate change and socially responsible investments (SRI), as related to University endowment investments. The Committee's work include consultations with members of the community and experts, and consideration of best

practices in responsible investment. It will culminate in the submission of a report to the Board.

CAMSR met again on December 3, 2018 and held consultation sessions with:

- Representatives of Senate
- Representatives of the Investment Committee of the Board of Governors, and Office of Investments
- Representatives of Student Associations (SSMU, PGSS and MCSS)
- Members of the Board of Governors who requested to speak to CAMSR
- Representatives of Divest McGill

Additional consultation sessions are scheduled for the Committee's meeting of February 18, 2019. The Committee will make every effort to submit its report to the Board of Governors by the last Board meeting of 2019.

The Committee will continue to provide updates of its work to the Board and to Senate at future meetings and to post information concerning its activities and plans on the Secretariat's website.

2. Budget Planning 2019 – 2020: Report I

The Board of Governors received an overview of the budget planning exercise for FY2020. A report on the budget planning process was presented to Senate at its meeting of December 5, 2018.

3. Update on the Recruitment to Retirement Project (R2R)

The Board was informed that this project continues to be of strategic importance to the University and the replacement of its Human Resources Information System (HRIS) remains necessary. The Committee was informed that organizational changes were made to the project team and that work on the project is currently slowed down as the project is being reassessed. It is anticipated that the IT Committee will consider a recommendation with respect to the project at its meeting in February 2019.
