


#### **Background**

- ► McGill's Strategic Academic Plan (2017-2022) commits the University to several enrolment targets as part of its key objectives. These targets include:
  - To increase the number of applications and the yield rate from all Québec CEGEPs and collèges;
  - To increase the number of new student registrations from Francophone CEGEPs and collèges by 15%;
  - To increase Indigenous student enrolment to 1,000;
  - To maintain international student enrolment at 25-30% of the total undergraduate population; and
  - To continue to attract top graduate students from around the world.


#### All CEGEPs and collèges: Applicants and New Registrations (10-year trend)

SAP Priority: To increase the number of applications and the yield rate from all Québec CEGEPs and collèges




#### Francophone and English CEGEPs and collèges: Applicants and New Registrations (5-year trend)

#### **Indigenous enrolment (5-year trend)**



Fall enrolment


#### International undergraduate enrolment by Immigration Group (10-year trend)


# Provincial university funding policy

#### **Update**

- Starting in 2018-2019, a revised weighting grid has been implemented for activities and programs, based on a new, streamlined academic classification system;
- 2. Starting in 2018-2019, the number of "special grants" has been reduced and folded into the teaching and/or support grants;
- 3. Between 2018-2019 and 2022-2023, a series of transitional envelopes are being created ensure that all universities benefit;
- 4. Starting in 2019-2020, Québec students must represent 50% of first-cycle (undergraduate) and second-cycle (master's level, non-research) students. This increases to 55% by 2026-2027;
- 5. Starting in 2019-2020, the tuition for all new and continuing first-cycle, international fee-paying students will be deregulated (i.e., institutions will keep all tuition paid by these students, but receive no government grant funding); and
- 6. Starting in 2019-2020, the tuition for all new and continuing second-cycle (non-research), international fee-paying students in non-research programs will be deregulated).


#### **Programs subject to deregulation starting in 2019-2020**

#### **Strategic Enrolment Plan Working Group**


- Strategic Enrolment Management is now overseen by Analysis, Planning, and Budget (APB), which works closely with the Faculties and Enrolment Services.

- Mandated to develop a new Strategic Enrolment Plan.
- ▶ Will lead consultations with community stakeholders to define what constitutes student success (by discipline and across the University) and to identify strategies that will attract students to the disciplines that align with their aptitudes and ambitions.



#### **Total enrolment by Level of Study (10-year trend)**





#### **Undergraduate enrolment by Level of Study (10-year trend)**
