SUBJECT: Further Response to the Question Regarding the Resolution of Grievances under the Committee of Student Grievances

ACTION REQUIRED: INFORMATION APPROVAL/DECISION

BACKGROUND:

The Question Regarding the Resolution of Grievances under the Committee on Student Grievances was submitted for the April 20, 2016 Senate meeting and a written response was prepared by the Secretary-General and circulated prior to the meeting.

During the April 20, 2016 Senate meeting, the Secretary-General was asked whether the following additional information may be provided: (1) the date of the incident giving rise to the filing of a grievance and (2) information on the type of grievance filed in each case. This information is indicated in columns 2 and 3, respectively, of the updated version of Table I below. For confidentiality reasons, with respect to the second question, only the articles of the *Charter of Students' Rights* cited by the Grievor to be infringed are provided.
