# 2017-2018 ANNUAL REPORT Report of the Research Integrity Officer Dr. Christina Wolfson Prepared August 2018

#### Introduction

The *Regulations Concerning the Investigation of Research Misconduct* (the Regulations) call for the Research Integrity Officer (RIO) to report annually to Senate and to the Board of Governors on the application of the Regulations. This is the **ninth** annual report presented to Senate and the Board of Governors in discharge of this obligation.

#### Background

The Regulations provide for an internal process for the assessment (inquiry) by the RIO and, where appropriate, the formal investigation of allegations of research misconduct brought against members of the University community regardless of faculty or discipline. The investigation committee membership and process to be followed are governed by the Regulations.

The tables below provide statistical information concerning allegations and their disposition for the past six academic years [2012-2013 to 2017-2018]. It is important to note that it is not uncommon for a complaint to include more than one allegation of research misconduct. What is presented below is the "primary allegation" as determined by the RIO.

#### **The Big Picture**

The nature of the allegations received varies from year to year. This year two new categories (Mismanagement of Research Funds and Misrepresentation of Credentials) are added to this table.

### The Source of Allegations

The sources of allegations are varied as shown in Table 2. While over the past 6 years the majority of allegations have come from external sources, in the 2017-2018, five of the six allegations received came from the McGill University Community (e.g. faculty members, graduate students and postdoctoral fellows, administrative units of the University). The majority of the respondents have been academic staff, though graduate students/postdoctoral fellows have also been named as respondents. The RIO works closely with Graduate and Postdoctoral Studies when the respondent is a graduate student or postdoctoral fellow.

The first step following the receipt of an allegation is an inquiry conducted by the RIO. The possible outcomes of the RIO inquiry are: insufficient evidence to proceed to an investigation; admission of guilt; or sufficient evidence to proceed to an investigation. Inquiries only or Investigations have taken place in twenty-six cases over the past six years. Research misconduct was established in twelve cases. For completed cases, appropriate sanctions were applied.

# **Consultative Activities**

In addition to the formal allegations noted above, the RIO opened fifteen files and held preliminary discussions with current or former members of the McGill community who were concerned about an issue of research misconduct. No formal allegations of research misconduct were submitted to the RIO for any of these dossiers, the dossiers were closed.

# **Additional Statistical Reporting**

Each year in addition to the annual report to Senate, the RIO files the following annually:

- (a) In accordance with the <u>Tri-Agency Framework: Responsible Conduct of Research (2016)</u>, Article 4.5(b), institutions are required to report annually to the Secretariat on Responsible Conduct of Research matters involving Agency funding. This is a statistical report only.
- (b) Each institution which receives or applies for US Public Health Service research funding must report to the US Office of Research Integrity concerning any allegations of research misconduct involving U.S. Public Health Service funded research. This is a statistical report only.
- (c) For all allegations involving research funded by FRQ or in relation to allegations against a member of the McGill community based at an FRQ funded research institute, a letter, devoid of personal information must be forwarded to the FRQ with the decision concerning the disposition of the allegation (i.e. insufficient evidence to proceed to an investigation; admission of guilt; or sufficient evidence to proceed to an investigation).
