*Academic Policy Committee - Terms of Reference*

The Academic Policy Committee (“the Committee”) is a Standing Committee of Senate charged with making recommendations to Senate on all matters regarding academic policy. In particular, it shall, for the University and in consultation with faculties, develop proposals for the establishment and continuous review of academic programs, policies and structures, and proposals relating to teaching, learning, and research. The Committee may create subcommittees or working groups to deal with issues as appropriate.

The Committee shall review academic course and program proposals in order to determine whether they meet academic standards and are aligned with the academic mission and priorities of the University, whether they are based on an adequate body of knowledge, whether proposed teaching or learning methods and methods of evaluation of student performance are satisfactory, and whether the necessary human and material resources are in place.

APC approved, on December 14<sup>th</sup>, 2017, the closure of the McGill Summer Institute for the Study of Montreal and Quebec.

**5. Academic Unit Reviews**

In accordance with McGill's Regulations on Academic Unit Reviews, the documents pertaining to the following unit reviews were made available to APC on November 16<sup>th</sup>, 2017:

**6. APC Subcommittee on Teaching and Learning (STL)**

- STL revised the nomination guidelines for the Principal's Prize for Excellence in Teaching (PPET), further detailing the eligibility criteria and the course evaluation data to be submitted, and making changes to the course evaluation comments accompanying the dossier.
- STL heard that the functionality of the *mycourses* platform does not meet the requirements of the University and that a business case for a new platform has been submitted to IT.
- STL discussed a proposal by TLS to host an Undergraduate Research Conference at McGill.
- STL was also updated on the development of online offerings at McGill following the contract breakdown with Everspring.
- STL reviewed the proposed pedagogical principles drafted by ESAAC that will be used to guide the revision of the Student Assessment Policy. The Subcommittee also discussed the Faculty of Medicine's Strategic Education Plan.

**7. APC Subcommittee on Courses and Teaching Programs (SCTP)**

SCTP completed its regular review of courses and teaching programs proposals.

**8. Research Advisory Council (RAC)**

RAC received two applications for status as an officially recognized McGill Research Centre:

- The Azrieli Centre for Autism Research (Faculty of Medicine), which was endorsed by RAC on December 7<sup>th</sup>, 2017. It received its official McGill status at a meeting of the Board of Governors on March 29<sup>th</sup>, 2018.

- The Yan P. Lin Centre for the Study of Freedom and Global Orders in the Ancient and Modern Worlds (Faculty of Arts) which was endorsed by RAC on December 7<sup>th</sup>, 2017. It received its official McGill status at a meeting of the Board of Governors on March 29<sup>th</sup>, 2018. RAC was also consulted on diverse regulations and policies that relate to research, such as the Research Asset Management Regulation, the Strategic Research Plan (2019-2023), the Policy on Research Centres, the Regulations on the Conduct of Research and the Equity, Diversity and Inclusion Plan. As per the its mandate, RAC members were consulted and/or updated on McGill's involvement in several major grant competitions and government research initiatives throughout the year.

## **9. Council of Graduate and Postdoctoral Studies (CGPS)**

- In addition to reviewing and approving new graduate programs, graduate program retirements, and major and minor revisions to existing graduate programs, CGPS also reviewed and approved the following:
- A Joint Doctoral Degree between McGill University and the Communauté Université Grenoble Alpes, France for students registered in the Ph.D. in Mathematics and Statistics (at McGill) and students registered in the Doctorat en mathématiques, sciences et technologie de l'information, informatique MSTII (at Communauté Université Grenoble Alpes).

## **10. APC Subcommittee on Continuing Education (SCE)**

- SCE submitted a proposal to expand its membership to APC in an effort to better reflect the diversity and number of continuing education activities across the university's academic units. APC approved its request on February 8<sup>th</sup>, 2018 and members from the Faculties of Agricultural and Environmental Sciences, Arts, Education and Law should be appointed to SCE shortly. SCE also held two half-day discussions around professional development and online platforms.

## **11. APC Subcommittee on Professional Programs (SPP)**

- The Subcommittee on Professional Programs did not meet in 2017/2018. Its terms of reference and composition were revised and approved by APC on May 9<sup>th</sup>, 2018.

CGPS will work on establishing a framework for joint programs and degrees. New Graduate Programs proposals will be considered as they arise.

- Streamlining communication with instructors
- Recognizing and rewarding teaching
- Developing students' learning skills

## **4. Research matters for APC consideration**

RAC's work plan includes:

- The Regulations on the Conduct of Research
- The procedures related to the Policy on Research Centres
- The Strategic Research Plan

RAC will also look at proposals to establish new Research Centres as they arise and review



the status of provisional Research Centres as necessary.

## **5. Professional Programs**

A call for nominations has been made recently and the membership of the Subcommittee on Professional Programs should be submitted to APC shortly. It is expected that SoPP will hold its first meeting in a near future.

## **6. Continuing Education**

SCE will focus on:

- Inviting guests to present Continuing Education activities and developments at McGill
- Connecting with the existing McGill Online Working Group.
- Turning the reporting template into a LimeSurvey and collecting data for 2015-16, 2016-17 and 2017-18
- Discussing the potential use of Destiny at McGill and the need for a University Policy on the use of such a software for non-credit offerings at McGill.
- Exploring the different online platforms used throughout the university, via presentations, and drawing up an inventory of systems used at McGill to deliver online content.
- Increasing the visibility of the subcommittee's work and the profile of continuing education activities at McGill.
