# STANDING COMMITTEE ON SABBATIC LEAVES

#### ANNUAL REPORT TO SENATE 2007-2008

#### **Mandate**

Section 10.1 of the *Regulations on Sabbatic Leaves* states:

A Standing Committee on Sabbatic Leaves, composed of two persons named by MAUT, **one** by the Principal, and the chair selected by the named members, is responsible for reporting annually to Senate on the administration of the present sabbatic regulations.

#### **Report**

The 2007-2008 sabbatic "cohort" was the first to be processed in accordance with the revised *Regulations on Sabbatic Leave* which came into effect in June 2007. No difficulties were encountered in the processing of the largest cohort of applications in recent history. Applicants, chairs and deans appear to have adjusted well to the new application forms introduced in light of the changes to the regulations.

The sabbatic leave statistics for 2007-2008, broken down by Faculty, are summarized in the attached appendix. The annual statistics from 2002-03 through 2006-07 are also provided for the information of Senate in Appendix A. It will be noted that in the past two years there has been an increase in sabbatic applications, no doubt attributable to the push for "academic renewal" which commenced in 2000.

In brief, for 2007-2008 there were 162 applications of which one was premature. All other applicants (161) met the criteria for eligibility and their applications were approved; however, 10 were formally requested to defer their leaves. Of the 161 applicants, 74 were first time applicants.
