ISSUE: Proposed Student Services Fee Schedule 2009-10

BACKGROUND & RATIONALE: The Senate Committee on Student Services (CSS) recommends setting the 2009-10 Student Services fees as indicated in the attached table.

Results of the Winter 2009 SSMU referendum signify undergraduate students' acceptance of the fees. An entente between SSMU and the University, as required by Minister of Education, Leisure and Sports (MELS), will be signed to formalize our agreement.

Fee increases were not approved in the Winter 2009 PGSS referendum; graduate fees will therefore remain at 2008-09 levels, but graduate students will have reduced access to some services and/or will be charged fees for some services.

MOTION OR RESOLUTION FOR APPROVAL: Be it resolved that the 2009-10 Student Services fee recommendations be received by Senate and forwarded to the Board of Governors for approval, so that the fees may be included in the University Fee schedule for 2009-10.

PRIOR CONSULTATION: The Senate Committee on Student Services (CSS), Students Society of McGill University (SSMU), Post-Graduate Students Society (PGSS)

NEXT STEPS: Send for approval to the Board of Governors. Pending that approval, an entente between SSMU and the University will be signed and sent to MELS.
