Current Terms of Reference

<u>Note:</u> There are proposed changes to the terms of reference for the UCSSA that have been submitted for approval to Senate Nominating Committee.

- 1. The committee shall review and formulate policies on all matters pertaining to awards made by the University to its students. Awards shall include scholarships, fellowships, prizes, medals, bursaries, and loans.
- 2. The committee shall approve in the name of Senate new awards and changes in the conditions of existing awards, including their values.
- 3. The committee shall award scholarships and prizes to incoming and in-course undergraduates. All faculties making such awards under their jurisdiction shall report these to the committee.
- 4. Fellowships, scholarships, and prizes for graduate students will be awarded by the Office of Graduate and Postdoctoral Studies which shall report annually to the committee.
- 5. Loans, bursaries, and work study support shall be awarded by the Student Aid Office. The Director of the Student Aid Office shall report annually to the committee.
- 6. The committee shall report annually to Senate.

I. FOR THE APPROVAL OF SENATE

There were no items for the approval of Senate.

II. APPROVED IN THE NAME OF SENATE

The following table provides a brief summary of the activities of UCSSA regarding new and revised awards:

New awards approved	50

In addition, the term "Minimum Value" in all descriptions of newly approved and revised awards is being replaced with "Estimated Value", to reflect the fact that investment earnings may fluctuate; all references to "Metals and Materials Coop" were changed to "Materials Coop"; and all references to "Faculty of Music" were changed to "Schulich School of Music".

III. FOR THE INFORMATION OF SENATE

Appendices I through IV summarize information regarding funding provided to entering and continuing undergraduate and graduate students. Compared to the previous year, 2005-06 saw a 3.7% increase in the value of McGill Loans, a 16.72% increase in the value of McGill Bursaries, a 4.6% decrease in the value of Work Study subsidies, a 13.72% increase in the value of Scholarships, and a 26.72% increase in the value of Faculty Awards from 2004-05. Additionally, 2005-06 saw a 18.8% increase in fellowships to students of Quebec origin, a 15.8% increase in fellowships to students originating from the rest of Canada and a 8% increase in fellowships to students of International origin.

Activities in 2005-06

UCSSA approved that, with the donor's authorization, faculties could split a scholarship, ensuring greater flexibility and equity regarding the distribution of in-course scholarships.

UCSSA approved the creation of non-renewable Recruitment Scholarships and Fellowships, valued at \$5,000, which will enhance the ability of faculties to offer financial incentives to new students.

UCSSA supported a change in format to the Convocation Booklet that was proposed by the Office of the Secretariat.

A workgroup was established with a mandate to review McGill's current practice of awarding graduation honorifics (e.g., Dean's Honour List, Distinction, and Great Distinction), to collect information on the practice of peer institutions, and to propose recommendations to UCSSA.

UCSSA supported a pilot project whereby entering students who received a Certificate of Merit were given a modest monetary award as well. Of interest was the project's impact on yield.

UCSSA agreed to establish, exclusive to the Faculty of Medicine, a non-renewable Entrance Scholarship called a "Professional Recruitment Award", to increase equity in the distribution of scholarships among students.

IV. STATEMENT TO SENATE - PLANS AND PRIORITIES FOR 2006-07

In accordance with its mandate, the UCSSA will review and propose policies on all matters pertaining to awards made by the University to its students.

The UCSSA will continue to approve, in the name of Senate, new awards and changes to existing awards, including scholarships, fellowships, prizes, medals, bursaries, and loans.

In addition to the regular order of business, the UCSSA will review entrance scholarships (including current criteria for allocation and renewal), the nomination process for the Governor General Awards, and the Terms of Reference for the UCSSA. The Committee will receive reports from the Workgroup on Distinction and Great Distinction and from ARR regarding admission yields resulting from the Certificate of Merit pilot project. The UCSSA will also approve an Award Template procedure that will decrease the approval time for awards, thereby facilitating fundraising by the faculties.
