COMMITTEE TERMS OF REFERENCE

## **University Tenure Committee**

Action: Approve the Nominating Committee's recommendation that term lengths on University Tenure Committee slates be extended from two to three years, commencing May 1<sup>st</sup> of each year.

Regulation 5.28.2 of the Regulations Relating to the Employment of Academic Staff states:

The Secretary-General or her or his delegate shall appoint the other three members to each University Tenure Committee from the list approved by Senate (the "Senate list") for each faculty. The Senate list shall be composed of:

- i) in the case of faculties with departments, nine tenured members of the academic staff who do not hold appointment in the same faculty as the members chosen under Section 5.28.1; and
- ii) in the case of faculties without departments, six tenured members of the academic staff who do not hold appointment in the same faculty as the members chosen under Section 5.28.1.

Membership of the Senate list shall be for a two-year renewable term.

The term length of three years would allow Senate to more efficiently populate the slates each year, and would ensure that the university more fully benefit from faculty members' expertise. It would also align the terms with those of Statutory Selection Committees.

## Ad Hoc Committee on the Recording and Transmission of Senate Meetings

Action: Approve the Nominating Committee's recommended Terms of Reference for the Ad Hoc Committee on the Recording and Transmission of Senate Meetings.

# Terms of Reference

The Ad Hoc Committee on the Recording and Transmission of Senate Meetings is an ad hoc committee of Senate charged with exploring options and advising Senate with respect to the recording and transmission of Senate meetings.

The Committee shall report to Senate taking into account:

- 1. perceived and established interests of the McGill community in virtual access to Senate deliberations (in open session);
- 2. technical options that are available, including various methods of recording, transmitting, and preserving the recording of Senate meetings;
- 3. options that are available for editing, including the option to select the parts of Senate meetings that would be recorded and/or transmitted;
- 4. recording and transmission practices and procedures in comparable bodies;
- 5. potential impacts on individual Senators and the overall conduct of discussion and debate at Senate meetings; and
- 6. potential costs incurred in the recording and transmission of Senate meetings and how these costs should be covered.

#### The Committee shall:

- 1. consult with Senators and members of the McGill community as it considers appropriate;
- 2. report to Senate, in writing, with any recommendations related to recording and/or transmitting Senate meetings; and
- 3. submit a report to the Steering Committee and to Senate when its work is complete.
