Re: Appointment of Nikhil Srinidhi, Engineering Senator, to APC

To members of the Senate Nominating Committee,

I would like to give a brief explanation as to the context of Edward Chiang's (former Engineering Senator) resignation and the appointment of Nikhil Srinidhi as his replacement. I would also like to ask the Nominating Committee exceptionally to recommend the appointment of Mr. Srinidhi to the Academic Policy Committee by e-vote.

Over the summer, Mr. Chiang informed me that he had received an internship first semester at RIM in Ottawa. Normally in these cases, the SSMU regulations state that such a person would be unqualified to serve as a Senator. However, given that he would be back and able to serve full time in January, I decided to give Mr. Chiang a probationary period of one month (September). Through the end of the summer and into September, I consulted with both the Engineering Undergraduate Society (EUS) executive and council. After much discussion, both bodies determined that Mr. Chiang's performance and participation was sub-par and could not continue. This view was shared by my fellow student Senators. In my capacity as VP University Affairs, I asked Mr. Chiang to step down – which he did immediately. As per SSMU By-Laws, the EUS collected names of his possible replacements and provided viable candidates to the Senate Caucus, which subsequently elected Mr. Srinidhi.

Mr. Srinidhi is also interested in filling Mr. Chiang's vacancy on the Academic Policy Committee. I believe that Mr. Srinidhi is thoroughly qualified based on his resume and my interactions with him. He will be a very good addition to the student voice on APC. An evote would allow Senate to appoint Mr. Srinidhi to APC on November 14, which would allow him to fulfill his Senatorial duties as of that date.

Please take this into consideration as you cast your vote.
