## ACTIVITIES UNDERTAKEN DURING THE ACADEMIC YEAR

This document summarizes the activities of McGill University Library for the 2013-14 academic year as discussed at meetings of the Senate Committee on Libraries:

Reports were made at each meeting by the Trenholme Dean of Libraries, C. Colleen Cook, on achievements toward meeting the goals in the Libraries’ strategic plan.

## Client Relationship Management

- The mergers of the Education Library with the Humanites \& Social Sciences Library and the Life Sciences Library with the Schulich Library occurred over the summer of 2013. Both spaces will still house Faculty-specific and/or reserve materials which will be accessible for limited hours. The rest of the space is now being used as student works and study space, falling under the jurisdiction of their respective Faculties.
- As of October 1, 2013, extended hours (24/5) will resume in the following libraries: Humanities \& Social Sciences Library, Schulich Library and the Nahum Gelber Law Library.
o However, it is not possible to allow other libraries to be open with the same hours. University Security and library staff are working to the maximum possible capacity given the current budget allotted for this purpose.
- The Faculty of Arts has re-instated the Humanities \& Social Sciences Library Advisory Committee in order to improve the flow of communication between the Faculty of Arts and Libraries’ administration.
- A plan to set up a 'Research Commons' was set in motion, which included the assembly of all research and teaching-related units into one space (eg. TLS and the Writing Centre) and also a redefinition of the job description of a Liaison Librarian to include more flexibility to better serve the changing learning habits of both students and teachers (eg. more emphasis on digital resources and learning with technology).


## Collection Management

- The much-anticipated Voltaire collection arrived in the Fall of 2013, with the help of fund-raising efforts and philantrophic donations. A symposium on the collection is planned for the near future, and there has been a lot of good press surrounding the acquisition, some of which is on display in the Rare Books section.
- Currency fluctuation and the inflation of serial prices continue to be a concern for the Libraries’ Collection Budget.
- The concept of 'open-access' is being spread to the Faculties by Associate Dean (Digital Initiatives) Jenn Riley and her team. The practice of publishing articles in free or 'open-access'
serial publications would greatly off-set the onerous cost of serials at the Library and could make many scholarly articles more accessible to students, faculty and the public.
- A number of ideas, including off-site condensed storage systems are being considered to deal with the growth of the libraries’ serials and monograph collections. A plan to eliminate duplicate copies of serial print materials, and inversely, to preserve the rare and unique monograph collection, is being formulated.
o One idea is to join together with other universities in the Montreal area to create a shared, off-site condensed storage facility and retrival system to house the less-circulated books from these institutions.
o The over-arching theme behind these ideas is to create more user-friendly library spaces, while still maintaining convenient access to any print material in the Libraries' collection.


## Facilities, Resources, Infrastructure Management

- HVAC system was replaced in the Life Sciences Library space, including the Osler Library in spring of 2014
- The new and improved Library terrace was completed in early 2014 and 'unveiled’ as a smokefree space in late May.
- Feasability Study: in conjunction with Robert Couvrette, Associate VP (University Services), this study was conducted to assess the needs of the Libraries in terms of physical space, storage facilities and convenience for the user
o Upon completion of this study, a call for tenders was drafted in Winter 2014 and Dean Cook hopes to have tangible results by Fall 2014

Staff Development and Management

- 2 new Associate Deans were appointed in 2013: Daniel Boyer was appointed as Associate Dean (User Services) on 1 August 2013, and Jenn Riley was hired in a new role of Associate Dean, (Digital Initiatives). She started her term on 1 November, 2013.
