#### BILINGUAL CHILD AND YOUTH COUNSELLOR (TEMPORARY, FULL TIME OPPORTUNITY – 12 MONTHS) The Children's Aid Society of Ottawa (CASO)

Child & Youth Counsellors work in collaboration and consultation with other Society staff, with the child and his/her family, and any care providers. This includes supervising access visits with the children who are currently in the care of the CASO. The goal of the Society, within Child Access service delivery, is to provide appropriate time and resources to allow children to visit with their parents and/or other family members, under supervised conditions. This ensures their safety and well-being, while allowing the children to maintain relationships, which are significant and important to them.

#### Hours of Work:

The worker is expected to work flexible hours (which may include days, evenings and weekends) in order to meet the needs of the client. Schedules are determined two (2) weeks in advance based on program needs. Open availability will be considered an asset.

#### **Requirements:**

- Child & Youth Worker Diploma, Social Services Diploma or B.A, in a related field.
- Two years of related experience working with children and/or youth.
- Demonstrated knowledge, skills and abilities to work effectively with diverse communities and Aboriginal Peoples.
- Valid Driver's license and access or ownership to a vehicle is required.
- Cell phone is required.
- Proficiency in both English and French (in oral and in writing).

#### FOSTER CARE/ADOPTION WORKER – KINSHIP SERVICES (TEMPORARY, FULL TIME OPPORTUNITY – 12 MONTHS – ENGLISH POSITION) - The Children's Aid Society of Ottawa (CASO)

We are currently searching for a dynamic person to join the third largest Children's Aid Society in Ontario, to fulfill the role of a foster care/adoption worker with our kinship services team.

#### The Position:

The foster care/adoption worker is responsible for promoting permanency, safety and well-being of children and youth in kin arrangements through the successful engagement, assessment, selection and where appropriate, monitoring, support and ongoing evaluations of kin families both within care and out of care status and through the successful recruitment, assessment, selection, monitoring, support and ongoing evaluations of adoptive and foster families. This worker will also conduct searches for kin options, working with birth families, identifying and selecting potential safe alternate living arrangements in the child's extended family, community or band when, for child protection reasons, the child is not maintained in his or her own home. In addition, the worker may provide counseling to birth/kinship parents to facilitate openness when the child is moving onto permanency through legal custody or adoption.

The worker provides service to children and families within the legal framework of the Ontario Child and Family <u>Services Act</u> and related legislation, and the policies and procedures of the Children's Aid Society of Ottawa and the ministry of children and youth services.

The worker is expected to work flexible hours in order to meet the needs of the care providers and the children living in these arrangements. Monday to Friday, from 8:30 a.m. to 4:30 p.m. + flexibility. The worker is also expected to work flexible hours to meet the needs of the client.

#### **Qualifications:**

- BSW, MSW or bachelor's degree in a related field with relevant work experience;
- 2 years' experience working with families and children;
- kinship experience preferred;
- training and/or knowledge of pride and safe is an asset;
- familiarity with all relevant legislation, regulations and standards related to foster care and adoption as well as the society's policies and procedures;
- understanding of kinship and adoption regulations is required;
- demonstrated knowledge, skills and abilities to work in cross-cultural situations;
- excellent clinical and assessment skills;
- demonstrated administrative and organizational skills;
- strong interpersonal skills and ability to work within a team;
- superior oral and written communication skills in English are required.
