The LICM is staffed by McGill law students, although it is an independent organization. Through its Advocacy services, it acts as advisor to McGill students in their academic disputes with the University. Volunteers do not provide legal advice; they only provide information.

RESIDENT LIFE MANAGER (RLM)

The role of the Residence Life Manager is to create and sustain a sense of community in their hall, supervise the hall's team of Floor Fellows, serve as a general resource person for students and staff in the residence hall, support and interact with the hall councils, and act as a Disciplinary Officer of the University when required. RLMs oversee a grouping of halls or a single large hall and will live in or near the halls for which they are responsible. As professionals with experience in the fields of residence life, student affairs and other learning/helping professions, they are responsible for educational programming, training and developing student staff (Floor Fellows), serve as a support and resource for resident students as they adjust to University life, provide administrative and operational support, serve as an early alert system for emotional, academic and mental health issues among students, and provide crisis management.
