**Course Objective:** To prepare students for learning in clinical practicum courses 1 and 2 (OCC1 501/502).

**Course Structure:** Prior to M1, Qualifying Year (QY)/U3 students will participate in 10 hours of preparatory seminars in term A (fall) and B(winter).

A grade of Fail will result in non-admission to OCC1-501 Clinical Practicum 1 which may result in delayed progression through the program. Students who must miss a mandatory seminar for exceptional circumstances must make alternate arrangements with the course instructors.
