MEMORANDUM OF AGREEMENT made and entered into at the City and District of Montreal, Province of Quebec.

BETWEEN **McGILL UNIVERSITY**, a university duly constituted by charter, having its principal office at 845 Sherbrooke Street West, in the City and District of Montreal, Province of Quebec,
(hereinafter referred to as the "University")

AND **STUDENTS' SOCIETY OF MCGILL UNIVERSITY**, an incorporated association having its principal office at 1200-3600 McTavish Street, in the City and District of Montreal, Province of Quebec,
(hereinafter referred to as the "Association")

WHEREAS the Association represents the interests of its membership through its democratic processes, recognizing the supremacy of its General Assembly to enact or overturn all decisions made in its various governing bodies;

WHEREAS the University is committed to protecting the rights of the undergraduate student body as represented by the Association;

WHEREAS the University recognizes student groups as integral members of the University community;

WHEREAS the University and the Association wish to enter into a memorandum of agreement for a term beginning on June 1, 2024 and ending on May 31, 2029, respecting various matters including the assessment and collection of fees from students and the operation of University accounts for such fees and wish to enter into a new agreement, in replacement of the previous agreement;

WHEREAS a referendum of members of the Association approved the collection of fees for its operating expenses and the support of its activities;

WHEREAS, on the basis of said referendum, McGill University collects fees from regularly registered undergraduate McGill students which constitutes the members of the Association for said purposes;

WHEREAS Association was incorporated on April 22, 1999 by Letters Patent issued pursuant to Part III of the Companies Act (Quebec) **N.E.Q 1164473952**;

WHEREAS the Association was accredited in April 2003 in accordance with the *Act Respecting the Accreditation and Financing of Students' Associations R.S.Q., chapter A-3.01* representing all undergraduate students at the downtown campus of McGill University, except students in continuing studies; and

WHEREAS the University and the Association are committed to preserving their positive relationship and in preserving the particular nature of the student associations, and

consequently the parties intend to establish their relationship on the principles of good faith and the terms of this agreement shall be interpreted on that basis;

NOW THEREFORE, THE PRESENT AGREEMENT WITNESSES:

1. COLLECTION OF ASSOCIATION FEES

1.1 The University shall collect in each of the fall and winter sessions during the term of the present Agreement all fees from students duly registered at the University and assessed by the Association, such fees (the "Association Fees") to be used by the Association for its operating expenses and the support of the Association. The current Association Fee Schedule appears as **Appendix A** hereto.

The University shall collect and remit to the Association the association fees for the Nursing Undergraduate Society (NUS), Physical and Occupational Therapy Undergraduate Association (POTUS), and the Social Work Students' Association (SWSA), formerly recognized by the University as independent students' associations and currently designated by the Associations as affiliated associations. The association fees for these three affiliated associations appear in **Appendix A** hereto and shall be remitted to the Association for the benefit of the affiliated associations.

1.2 The Association Fees shall be included in the total student fee assessed by the University in respect of students and all University regulations pertaining to the assessment and collection of fees shall apply thereto.

1.3 The Association Fees shall be distributed yearly as follows:

1.3.1 The **first distribution** of the Association Fees shall be paid to the Association on September 15th and shall reflect fee assessments from June 1st to August 31st.

1.3.2 The **second distribution** of the Association Fees shall be paid on November 15th and shall reflect the balance of the Fall Term assessments as at October 31st. There shall be no holdback of fees for either of these remittances.

1.3.3 The **third distribution** of the Association Fees shall be paid on February 15th and shall reflect the Winter Term fee assessments as at January 31st. An amount equal to 10% of the amount to be paid as the third distribution shall be held back by the University to account for changes in student registration occurring from February 1st to May 31st.

1.3.4 The **final distribution** of Association Fees shall be paid on June 15th and shall reflect assessment as at May 31st, less the 1 % fee for bad debt charges (in accordance with Section 1.4), the Annual Administrative Fee (in accordance with Section 2.1) and any other amounts owed to the University as at May 31st.

1.4 No charges shall be levied by the University for the collection of the Association Fees; however, the University shall be entitled to receive 1% of the total fees assessed in each term as relief for the collection of bad debts. The University shall provide the

Association information on the level of bad debt resulting from its members at the request of the Association.

- 1.5 Upon prior written agreement of the parties, Association Fees may be credited to an internal account of the University for the exclusive use of the Association.
- 1.6 No adjustments to the Association's fees shall be applied or collected by the University unless the Deputy Provost (Student Life and Learning) has confirmed in writing that the formalities required by the Association's Constitution in respect of a referendum for fee adjustments and applicable law have been followed.
- 1.7 All requests for new fees or fee changes must be sent in writing to the Deputy Provost (Student Life and Learning).
- 1.8 As soon as possible, but no later than three (3) calendar weeks prior to the date of any referendum, the Association shall provide the Deputy Provost (Student Life and Learning) with a copy of the proposed question, and the Deputy Provost (Student Life and Learning) shall reply within two (2) calendar weeks of receipt of the referendum question. If the University has any concerns, the parties shall attempt to resolve the matter to their mutual satisfaction. In the event the University has continued concerns, the Association shall modify or withdraw the question.

The deadlines to submit referendum questions for review and to submit referendum results to the Deputy Provost (Student Life and Learning) are stipulated in the table below.

2. ACCOUNTING SERVICES

- 2.1 The University shall provide certain accounting services to the Association for an Annual Administrative Fee in accordance with the schedule contained in **Appendix B**. The services to be provided on Minerva will include the following:
 - 2.1.1 Preparation of payroll cheques and T4, TP4 forms for all regular staff with McGill employment status.
 - 2.1.2 Monthly trust fund statements indicating fee revenues, distributions and expenses resulting in year-to-date totals.

The Association shall request security access at the beginning of each mandate to access Minerva reports. The President of the Association must authorize all requests for access, and should the President require access,

then two vice-presidents of the Association must authorize their request. Security authorization to Minerva reports shall terminate each year on June 15th. Employees of the Association who have been given access may keep their access upon confirmation by the current year's President.

2.1.3 Provision of regular lists of the Association's membership on a scheduled basis; weekly in August/September and monthly the remaining months. The lists shall include, as available, the member's name, mailing address, permanent address, email address, telephone number, year of study and primary department.

2.2 Should the Association require any other lists, data sets or any other type of information on their membership or its financial records not already provided for in Section 2.1 above or elsewhere in this Memorandum of Agreement, the University shall give effect to the request to the extent allowed by law and subject to the payment of an appropriate fee, and upon prior notice of at least three (3) calendar weeks sent to the Director, Student Accounts Office. This fee will be identified prior to fulfilling the request. The University is subject to the provisions of the Quebec *Act Respecting Access to Documents held by Public Bodies and the Protection of Personal Information* and therefore reserves the right to refuse to give effect to a request.

2.3 Notwithstanding Section 2.1, should any programming changes be required to be performed by the University's IT Infrastructure & Information Security (IIS) at the request of the Association, the University reserves the right to charge the Association the hourly rate for the work to be performed.

2.4 The University shall not draw any funds from the account maintained by the University for the use of the Association or from the fees collected by the University for the Association without the Association's prior written approval, unless exercised as a remedy pursuant to Section 9.1 hereof.

3. LOANS AND GRANTS

The Association may apply to the University from time to time for loans and grants in aid of activities or projects, the granting of which shall be in the sole discretion of the University.

4. STAFF STATUS

All staff hired by the Association shall be exclusively employees of the Association and not of the University. The working conditions, including payroll, of the Association's staff shall be determined solely by the Association. Any dispute arising between the Association and its staff shall be the sole responsibility of the Association.

5. INSURANCE

5.1 The Association shall ensure that its officers and employees are covered under the terms of an Employee Dishonesty Policy with a reputable licensed insurer, to maintain such

policy in force at all times during the term of the present Agreement and to provide the University each year with a copy of such policy.

- 5.2 The Association shall be solely responsible for obtaining appropriate insurance necessary to conduct its activities, including and without limitation, comprehensive general liability insurance including but not limited to libel, slander, defamation of character, loss of property damages and personal damages, and shall name the University as Additional Insured.
- 5.3 The Association shall provide evidence of coverage upon execution of the Agreement and annually thereafter to the Deputy Provost (Student Life and Learning) with a copy to McGill Risk Advisory and Insurance Services. Evidence shall take the form of true copies of the relevant insurance policy or renewal certificate, as the case may be.
- 5.4 The Association shall hold harmless the University, its officers, employees and agents of and from any and all suits, claims or demands, and reasonable costs and expenses that may arise by reason of the operation of activities of the Association, or any act, neglect, omission of the Association, its directors, officers, employees, agents or persons engaged or retained by it.
- 5.5 The University shall hold harmless the Association, its officers, employees and agents of and from any and all suits, claims or demands, and reasonable costs and expenses that may arise by reason of the fault of the University.
- 5.6 The University shall not be liable for damages suffered by the Association resulting from the fault, negligence, acts or omissions attributable to a third party even if such third party is a person whom the University has allowed to use or to have access to such space.

6. MAINTENANCE AND AUDITING OF ACCOUNTS

- 6.1 All financial records, books and accounts of the Association shall be maintained in accordance with generally accepted accounting principles consistently applied.
- 6.2 The Association shall provide the University with a copy of its annual audited financial statements within 120 calendar days of each financial year-end. The Association's financial year end is May 31st.
- 6.3 Upon reasonable notice from the University and upon reasonable cause, the Association shall make available for audit, at the University's sole cost and expense all documents relating to the Association's:
 - 6.3.1 current contracts and expenditures;
 - 6.3.2 projected contracts and expenditures; and
 - 6.3.3 books, records, and accounts.
- 6.4 The Association shall engage the services of a reputable auditing firm or chartered accountant in good standing with the Order of Chartered Professional Accountants of

Québec and acceptable to the University, acting reasonably, to prepare the Association's annual financial statements. The Association shall advise the University of the name of the auditing firm or chartered accountant.

7. USE OF THE MCGILL NAME OR EMBLEM

- 7.1 The Association recognizes that the University is the owner of the intellectual property in the word "McGill" and the McGill trademarks which are duly protected by the *Trademarks Act*.
- 7.2 On a non-exclusive basis and solely in connection with its activities related to its role as a student association and in accordance with this Agreement, the University hereby grants the Association the right to use the word "McGill" in its name as "**THE STUDENTS' SOCIETY OF MCGILL UNIVERSITY**". The present grant is not assignable.
- 7.3 The Association's name and logo shall be distinct from that of the University's in such a way that it does not cause confusion between the University and the Association. A copy of the Association's approved logo and trademark appears in **Appendix C**.
- 7.4 The University recognizes that the Association is the owner of the intellectual property of its name and trademarks, which are duly protected by *the Trademarks Act* so long as they conform with the representations of Sections 7.2 and 7.3 of the present agreement.
- 7.5 Any change to the Association's approved logo or trademark shall be submitted in advance for confirmation by the Deputy Provost (Student Life and Learning) that the proposed new logo or trademark conforms to the terms and conditions set out in this Section. Approval shall form an amendment to this agreement.
- 7.6 On a non-assignable and non-exclusive basis, and for the term of this Agreement and in accordance with its conditions, the University hereby grants those Association's accredited groups, clubs or services that do not have a separate agreement with the University (the "Groups") appearing in **Appendix F**, permission to use "McGill" in their names under the following conditions:
- 7.6.1 Each of the Groups shall identify themselves, in all their representations, as a group of the Association using the form:
"A [e.g. sports club, service ...] of the SSMU (Students' Society of McGill University)"
- 7.6.2 Groups wishing to use the McGill name shall register the name and a description of the Group's activities with the Office of the Deputy Provost (Student Life and Learning) using the provided web form found on the Student Associations section of the Deputy Provost (Student Life and Learning) website.
- 7.6.3 Groups wishing to use the McGill name shall do so under the understanding that they must comply with all McGill applicable policies and procedures, and will endeavor to not bring the McGill name into disrepute.

- 7.6.4 The Association or the Groups shall not use of the name "McGill" in relation to any sport or team, except where permission is granted in writing by the Deputy Provost (Student Life and Learning).
 - 7.6.5 McGill reserves the right to withdraw permission to use the McGill name at any time and for whatever reason, subject to notice and discussion with the Association.
 - 7.6.6 Groups shall not form a corporation using the McGill name, nor register any trademark containing the name McGill.
 - 7.6.7 The conditions set out for the use of the "McGill" name do not extend to the use of the McGill logo.
- 7.7 The list of Groups in **Appendix F** will be updated every year by June 1st, based on agreement between the Parties, and the Association shall provide a list of all the Groups upon the request of the University at any time to monitor compliance with this Agreement.
- 7.8 Neither the Association, nor any of the Groups, shall use the name of the University for any other purpose than those contemplated in this agreement without the prior written consent of the Deputy Provost (Student Life and Learning).
- 7.9 Except as provided in Section 7.11, neither the Association, nor any of the Groups, shall use the McGill logo or any other McGill trademarks.
- 7.10 For all Groups, and for all their activities, services, offerings, advertisements and websites, the Association shall respect the rights of the University as owner of the trade name "McGill".
- 7.11 For **event-specific permission** to use the name, or trademarks of the University, outside of the terms of this Agreement, the Association shall obtain express prior written consent from the Deputy Provost (Student Life and Learning). Permission shall be granted at the University's discretion and, where granted, is time-limited and not assignable. McGill reserves the right to withdraw such permission at any time and for whatever reason.
- 7.12 The Association shall ensure that all Groups are made aware of the conditions for the use of the McGill name or trademark, as outlined in this Agreement and the Association shall correct any misuse within thirty (30) working days from the Association becoming made aware of the misuse.

8. CONTRACTS AND LEGAL PROCEEDINGS

- 8.1 Any acts, contracts, and legal proceedings involving either party shall be the exclusive responsibility of that party.

- 8.2 Neither party shall enter into or execute any cheques, contracts, documents, instruments, receipts, leases or other agreements in the name of the other party or in any way engage the liability of the other party thereon by any other means.
- 8.3 The Association shall not solicit or receive any gift, grant or bequest in the name of the University without the prior written consent of the University.
- 8.4 Should any legal proceedings or claims be taken or made against either party as a result of an act of the other, the legal proceedings or claims shall be immediately referred to the other party and in the case of the Association, to its Legal Advisor, which shall deal with it in a timely manner and at its own expense. Any costs or expenses incurred by such litigation or claim including, *inter alia*, any legal fees, condemnation, order, settlement, interest, judicial and extra judicial fees and costs, shall be entirely at the charge of the other party.
- 8.5 Either party shall have the option to engage its own legal counsel to intervene in or direct any legal proceedings in respect of the other party where its interests are involved. In such a case, all expenses, extra-judicial fees and disbursements shall be borne exclusively by the party which has invoked this option.

9. RIGHT TO SET OFF

- 9.1 Should the University, following due notice to the Association, be required to pay any of the charges, costs, expenses, debts and claims which are by these presents to be borne exclusively by the Association, or should the Association be in any way indebted to the University, the University is authorized to collect or set off the said amount against the funds paid or payable to the Association pursuant to this Agreement.
- 9.2 In accordance with the present Agreement:
- 9.2.1 The University must provide the Association with a written notice of the charges, costs, expenses, debts and claims providing complete details and documents relating thereto.
 - 9.2.2 The Association shall have a delay of thirty (30) working days (or, if such notice is received between May 1st and August 31st, sixty (60) calendar days) after the receipt of such notice in which to resolve and/or remedy the matter.
 - 9.2.3 The University shall exercise its best effort to inform the Association as soon as possible within the same fiscal year (defined as the period June 1 st to May 31st) of any charges, costs, expenses, debts and claims on the part of the Association under this clause.

After taking these steps, the University is authorized to collect or set off the said amount against the funds paid or payable to the Association pursuant to this Agreement.

9.3 In the event of a dispute over the exercise of the right of set off, either party shall be entitled to submit the dispute to arbitration by giving the other party written notice no later than 90 calendar days from the date of a written notice of the dispute. Submission to arbitration shall be made in accordance with the provisions of the *Quebec Code of Civil Procedure* (Sections 620 and following) before one arbitrator chosen by the parties. The fees and expenses of the arbitrator shall be shared equally between the parties. Notwithstanding the foregoing, the parties agree that it is in their best interest to resolve any dispute amicably. The parties agree to engage in an open and respectful dialogue between the Deputy Provost (Student Life and Learning) and the President of the Association with the aim of arriving at an amicable resolution of the dispute.

10. LIQUOR PERMITS

10.1 The Association shall apply for and maintain in the Association's own name (a) permanent bar permit(s) for use only within the University Centre and (b) all necessary temporary liquor permits for any events and activities that the Association, or any of its Groups, may hold from time to time on University premises. The Association may not hold a grocery permit. For clarity, the Association may engage in non-commercial food-related activities such as the Food Pantry project.

10.2 The Association recognizes and reaffirms its commitment to respect Article 39 of the *Quebec Act Respecting Liquor Permits (chapter P-9.1)*.

10.3 The Association shall exercise its permits in accordance with all laws, municipal and government regulations as well as all internal requirements and policies of the University that include, but are not limited to those relating to:

- 10.3.1 hosting on campus events only in approved University locations;
- 10.3.2 advertising these campus events, and the cost of alcohol, in accordance with the law;
- 10.3.3 purchasing, storing (as applicable) and serving the alcoholic beverages at these events in accordance with the law;
- 10.3.4 adhering to all requirements with respect to building, fire, security and room capacity, and other legal requirements and University regulations as well as appropriate standards of conduct.

For greater clarity, for events hosted outside the University Centre, but still on campus premises, the Association:

- may not extend the Association's bar permits for within the University Centre to events occurring in other University buildings or on other University premises;
- may serve beer from kegs with prior event-specific written permission from the Deputy Provost (Student Life and Learning);
- shall serve beer or any other alcoholic beverages in non-plastic cups, cans or bottles; and

- such other conditions as set by the law and the University from time to time.

10.4 The Association shall hold harmless the University for any and all claims, fees or fines arising from its exercise or omission to exercise its rights and duties under such permits and as host of these events.

10.5 The Association shall ensure that with the exclusion of operations in a student bar the events hosted by the Association include activities that allow members to socialize without requiring the purchase or consumption of alcohol for participation in the activity or event.

11. STUDENT PUBLICATIONS

11.1 The University recognizes that the Association's role as a representative body of undergraduate students on the downtown campus may necessitate the publication of newspapers, newsletters and periodicals directed toward its members ("Publications"). For all such publications, whether in print or in electronic form:

11.1.1 the Publications shall display on the title page, the Association's logo and the name of the Publication as well as the following notice immediately below the Publications' name:

"Published by the SSMU (or Students' Society of McGill University)"

11.1.2 The Publication shall print the following notice on the second page or back cover page in at least 9-point font, or on the Publication's website:

"This Publication is published by the Students' Society of McGill University, an undergraduate student association at McGill-University". The content of this publication does not necessarily represent the views of the Students' Society of McGill University or of McGill University.

11.1.3 The Publications may not display the McGill name, crest or logo in its masthead.

11.2 The parties recognize that the editorial, reporting and advertising content of the Publications are the sole and exclusive responsibility of the Association. For greater certainty, the parties acknowledge that the University shall not be responsible or liable for the editorial, reporting or advertising content of the Publications.

11.3 The Association may distribute publications approved in writing by the Deputy Provost (Student Life and Learning) at locations approved in advance by the University.

11.4 Notwithstanding the generality of the foregoing, the permission granted to the Association under this Agreement does not extend to the distribution of commercial flyers and advertisements for third parties either placed loosely within the Publication or distributed with the Publication (whether or not placed on the newsstands), which

is strictly prohibited; however, this does not limit the ability to print advertisements in the Publications.

11.5 It is understood that subject to the provisions in this Agreement, the Association is permitted to produce, and distribute at no cost to its members, Association brochures and agendas.

12. REVENUE-GENERATING ACTIVITIES

The following are the general principles governing the revenue-generating activities of the Association:

12.1 With respect to revenue-generating activities in the University Center, the Association will undertake to discuss with the University significant changes in those revenue-generating activities.

12.2 With respect to revenue-generating activities outside the University Center, including delivery of food or drinks prepared inside the University Centre, the Association may engage in the revenue-generating activities on the University premises listed in **Appendix D**. Revenue-generating activities are defined as all operations that produce income or recover costs by providing goods or services to the University community or, in some cases, to the general public. The Association must receive the University's prior written approval for changes in the use of University space for revenue-generating activities. The Association must have the University's prior written agreement in signing any contracts or agreements with external third parties, for Association's revenue-generating purposes that lead to the use of University space and/or facilities outside the University Center by such external third parties.

12.3 When University space and/or facilities are used for revenue-generating activities, the University must be reimbursed appropriately for the costs associated with the use of such space and/or facilities; these may include but not be limited to the payment of electricity, janitorial and maintenance charges. The University shall provide the Association details and documents of such charges, upon request.

12.4 Any University space or facilities used for revenue-generating activities shall be subject to a lease arrangement which may include the payment of rent. All costs, taxes and fees associated with the use of the spaces or facilities that may become due is the responsibility of the Association.

12.5 The University and the Association will undertake to discuss contracts or agreements with external third parties regarding certain revenue-generating activities that may lead to the recovery of costs for the University as well as generate sufficient income to the benefit of both the University and the Association.

13. TELEPHONE, EMAIL, INTERNET, NETWORK, AND MAIL SYSTEMS

13.1 As long as the Association is located in a University building, the Association shall be entitled:

13.1.1 to telephone services from the University, including a McGill number, McGill credentials (as necessary), internal switching and University directory listings. Equipment to use telephone services must be purchased by the Association. No equipment other than that provided by McGill IIS may be attached to lines provided by McGill;

13.1.2 to purchase backbone connectivity and Internet access for the Association's computers. This may be subject to a separate agreement.

13.1.3 to use the University's email system subject to the Association, its employees, officers and volunteers, respecting University policies including but not limited to the *Policy on Responsible Use of McGill Information Technology Resources*.

13.1.4 to use the University's mailing system, including internal mail delivery.

13.2 The Association shall pay for all costs associated with the integration and use of these systems, as set from time to time by the relevant University offices. Integration in these University systems is a privilege, which may be revoked, should the University reasonably believe that the Association has used any system in a manner contravening McGill policy. The University shall provide the Association with such reasonable notice, as deemed to be appropriate, prior to revoking any of these systems.

13.3 The Association is prohibited from using the University's information technology resources (as defined in the Policy on Responsible Use of McGill Information Technology Resources) to store, process, transmit or accept any payment card data. For clarity, the Association warrants that it will not use the University-provided wired, wireless or telephony networks to store, process, transmit or accept payments. For example, the Association cannot use the McGill networks with any point-of-sale hardware or software.

14. REPRESENTATIONS AND COVENANTS OF THE ASSOCIATION

The Association represents, warrants and covenants that:

14.1 The charter documents, constitution and by-laws of the Association consist entirely of the documents remitted to the University concurrently with the execution of the present Agreement and which appear as **Appendix C**. The Constitution and By-laws of the Association are amended from time to time and are provided for reference purposes. The Parties agree that no clause in the Constitution or By-laws shall modify or supersede this Agreement.

- 14.2 A referendum of the Association members has been duly held in accordance with its constitution approving the existing Association Fees and such referendum continues to bind the Association and its members;
- 14.3 It is and shall maintain its status as a corporation under Part III of the *Quebec Companies Act* whose membership is limited to regularly registered undergraduate McGill students.
- 14.4 Directors and Officers of the Association are undergraduate degree students of the University, who: have been registered for at least 18 consecutive months (excluding authorized leaves of absence for up to 4 months) with no fewer than 18 credits prior to their initial election.
- 14.5 The term of office of any Director or Officer who ceases to meet the requirements during the term of their office, shall terminate at the time of such cessation.
- 14.6 The Association shall provide the names of nominees to the Deputy Provost (Student Life and Learning) to verify registration requirements before a nominee is approved as a candidate.
- 14.7 The Association commits to dealing, in accordance with its governing documents, with improper behaviour of its officers and board members, especially in cases that impact the ability of such individuals to carry out their roles, their credibility in such roles, or the reputation of the University by association with SSMU.
- 14.8 The University shall facilitate the availability of up to 12 credits of independent reading and research course, internships, or equivalent that allows Directors and Officers to use their experience as student leaders towards their academic progress as students, relative to their program requirements.
- 14.9 No member of the Association may act as Director or Officer of the Association while subject to any disciplinary sanction under the ***Code of Student Conduct and Disciplinary Procedures*** that has the effect of removing the student status.
- 14.10 The Association shall provide the Deputy Provost (Student Life and Learning) by December 1st each year with a copy of:
- 14.10.1 The Association's annual *Déclaration de mise-à-jour annuelle* with the Quebec Enterprise Register as proof that the Association has maintained its incorporated status;
 - 14.10.2 A list of Officers and Directors serving in the present academic year;
 - 14.10.3 A copy of the Association's annual **audited Financial Statements** prepared in accordance with Section 6 herein;
 - 14.10.4 A copy of the annual **Certificate of Insurance** obtained in accordance with Section 5 herein; and,

14.10.5 **Any changes to the documents** remitted to the University concurrently with the execution of the present Agreement at least once per semester.

15. NOTICE OF TERMINATION

15.1 Either party may terminate the Agreement at will by providing written notice (“Notice of Termination”) to the other party.

15.2 No default or cause is required to be identified or established to issue a Notice of Termination.

16. MEDIATION

16.1 Should either party issue a Notice of Termination, the parties shall attempt mediation with the goal of identifying and resolving differences that may have prompted the Notice of Termination.

16.2 Within three (3) working days following receipt of Notice of Termination, each party shall name two senior representatives to participate in mediation.

16.3 The mediation shall be conducted by an impartial, experienced, and certified mediator mutually agreed upon by the parties. If the parties cannot agree on a mediator within two weeks of the Notice of Termination, the mediation process herein can be forfeited, and the Agreement may be terminated at the date specified in the Notice of Termination.

16.4 The fees and costs of mediation shall be borne equally by the parties.

16.5 The mediation shall extend over six sessions within two months starting from the date of the Notice of Termination. The mediation may be extended if mutually agreed to by the parties.

16.6 The Agreement remains in effect during the mediation period and thereafter, provided the mediation is successful.

16.7 The parties agree to participate in mediation in good faith. This means that they shall make themselves reasonably available for mediation and will treat mediation discussions as confidential and without prejudice.

16.8 If the mediation is successful, a mediation agreement drawn up by the mediator in consultation with the parties is signed by the parties and treated by each as confidential.

16.9 If the mediation is unsuccessful after the expiry of the mediation period set forth above, as such may have been amended, the Agreement is terminated.

16.10 In the event of Agreement termination, nothing prevents the parties from resuming a contractual relationship through the negotiation of a new Memorandum of Agreement.

17. TERMINATION OF AGREEMENT

- 17.1 In the event the Agreement terminates, the Association will lose its rights under this Agreement and related contracts, including but not limited to access to campus spaces and use of the McGill name or emblem.
- 17.2 The Association commits, within two (2) working days following the termination the Agreement, to informing its members on its website and by email. In so doing, the Association shall set out the implications of the Agreement termination for undergraduate students who are members of the Association and clubs that operate under the auspices of the Associations.
- 17.3 The Association will report to the University, in a timely manner, any situation where collected student fees cannot be used for the express purpose for which they were collected.

18. LOCATION

- 18.1 In accordance with the Association's status as a student association, the University shall provide the Association with a room at no charge which shall constitute an office from which to conduct its activities. The location of this room shall be on or around the Montreal campus of the University and shall constitute the Association's principal premises, and appear in **Appendix E**.
- 18.2 The University further grants to the Association the use of the University space and/or facilities which appear in **Appendix E** at no charge for the term of this Agreement and for the stated purpose. No change may be made to the use of the space and/or facilities without the express prior approval of the Deputy Provost (Student Life and Learning).
- 18.3 Any request for additional space shall be made to the Deputy Provost (Student Life and Learning) and shall be subject to availability and may be evidenced by a separate lease agreement between the parties or confirmed in writing by the Deputy Provost (Student Life and Learning), whose confirmation shall constitute an amendment to this Agreement.
- 18.4 The University reserves the right to bill the Association for any extraordinary cleaning or repair necessitated as a result of an Association-sponsored activity in the University premises listed in either **Appendix D** or **E**.
- 18.5 The University and the Association will enter into an agreement (the "Management Agreement") by which the Association is appointed manager of the University Centre building (other than its garage)

19. TERM AND REVIEW

The term of the present agreement beginning on **June 1st, 2024**, and ending on **May 31st, 2029**. Twelve (12) months prior to the expiration of the term, the parties shall

review in good faith the terms and conditions with a view to renew on a mutually agreeable basis. In the event the parties are unable to agree on the terms of renewal, the terms of the present agreement shall be extended for a maximum of nine months.

20. NOTICE

Any notice to be given by the present Agreement shall be given to the University at its above-mentioned address to the attention of the **Deputy Provost (Student Life and Learning)**, and to the Association to the attention of its **President** or any available officer should the President not be available.

21. ENTIRE AGREEMENT

This present Agreement constitutes the entire agreement between the parties pertaining to the subject matter hereof and supersedes and replaces all prior agreements, undertakings, negotiations and discussions of the parties.

22. LANGUAGE

The parties to the present Agreement acknowledge having had the opportunity to negotiate the present Agreement and have requested that the present Agreement be drafted in the English language. 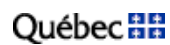



INDEPENDENT AUDITOR'S REPORT

To the Board of
Students' Society of McGill University

Qualified Opinion

We have audited the financial statements of Students' Society of McGill University (SSMU) (the Entity), which comprise the statement of financial position as at May 31, 2024, and the statements of operations and changes in fund balances and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of the Entity as at May 31, 2024, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Qualified Opinion

In common with many not-for-profit organizations, SSMU derives revenue from cash transactions the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our audit of these revenues was limited to the amounts recorded in the books of SSMU. Additionally, SSMU did not consolidate the accounts of SSMU Daycare Center Inc. / Centre de Garderie SSMU Inc., a not-for-profit organization, of which SSMU is deemed to have control over the operations and the deployment of its resources. Under Canadian accounting standards for not-for-profit organizations, SSMU should report the not-for-profit organization over which it has control by consolidating the controlled organization in its financial statements or by disclosing the total assets, total liabilities and net assets as at May 31, 2024 in addition to the revenues, expenses and cash flows for the year then ended. Therefore, we were not able to determine whether any adjustments might be necessary to revenues, excess (deficiency) of revenues over expenses and cash flows for the years ended May 31, 2024 and 2023, current assets as at May 31, 2024 and 2023, and fund balances as at June 1 and May 31 for both the 2024 and 2023 years. Our audit opinion on the financial statements for the year ended May 31, 2023 was modified accordingly because of the possible effects of these limitations of scope.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Entity in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Entity's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Entity's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Entity to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

1. Nature of the organization

The Students' Society of McGill University ("SSMU") incorporated the Student Center of McGill University on August 19, 1992 under part III of the Companies Act (Québec). On June 1, 2007, the Student Center of McGill University / Centre étudiant de l'Université McGill merged with Students' Society of McGill University / Association étudiante de l'Université McGill. As a result, SSMU was renamed Students' Society of McGill University / Association étudiante de l'Université McGill.

SSMU is a not-for-profit organization dedicated to providing various services to McGill students. The organization is exempt from income taxes.

2. Significant accounting policies

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CPA Canada Handbook - Accounting and include the following accounting policies:

Use of estimates

The preparation of these financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. These estimates are reviewed periodically and adjustments are made to income as appropriate in the year they become known.

Fund accounting

The Operating Fund records unrestricted resources which are available for the general operations of SSMU. This fund also records restricted resources for activities for which no restricted fund has been established.

The Capital Expenditures Reserve Fund was established in 1985 for the purpose of defraying and recording the cost of certain significant capital expenditures. The capital of this fund is derived from transfers made from the Operating Fund as deemed necessary to ensure the maintenance of an appropriate capital asset base.

The Awards of Distinction Reserve Fund was established in 1990 for the purpose of generating revenue to provide for SSMU's awards of distinction.

The Health and Dental Plan Reserve Fund was established in 2007 to ensure steady health care costs for students. The surplus from the SSMU Health and Dental plan fees at the end of the fiscal year must be maintained in this fund.

Fund accounting (continued)

The Student Life Fund was established in March 2010 for the purpose of enhancing student life on campus and to ensure that unused resources from other funds remain available for use in future years. The capital of the Student Life Fund is derived by unused resources from other sub or subsidiary funds, namely: Internal Fee Funded Funds, Fee Funded SSMU Services, Non-Fee Funded SSMU Services, Fee Funded Affiliated Student Associations and the Gerts Student Life Fund.

The University Centre Building Fund was established in October 2014 with the creation of the SSMU University Centre Building fee, in order to ensure any excess of funds from student fees are reserved and restricted for future lease payments.

Revenue recognition

The organization follows the deferral method of accounting for contributions and uses fund accounting.

Restricted contributions are recognized as revenue of the appropriate fund in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue of the appropriate fund when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Student fees, university centre building operations, general administration, funding, programming activities and services revenues are recognized by SSMU once the service is provided and collection is reasonably assured.

Gerts Bar revenues are recognized by SSMU when the service or goods are provided and collection is reasonably assured.

Restricted net investment income is recognized as revenue of the appropriate fund in the year in which the related expenses are incurred. Restricted net investment income that must be added to the principal amount of resources held for endowment is recognized as a direct increase in net assets. Unrestricted net investment income is recognized as revenue when earned.

Deferred revenues include revenues received in advance for rentals, handbook advertising and sponsorship.

Cash and cash equivalents

The SSMU's policy is to present bank balances under cash and cash equivalents, including bank overdrafts when bank balances that fluctuate frequently from being positive to overdrawn, and term deposits with a maturity period of under three months from the date of acquisition.

Capital assets

Capital assets are accounted for at cost. Amortization is calculated on their respective estimated useful lives using the straight-line method at the following rates and over the following periods:

Impairment of long-lived assets

When a capital asset no longer contributes to an organization's ability to provide goods and services, or the future economic benefits or service potential of the capital asset is less than its carrying value, the excess of its net carrying amount over its fair value or replacement cost is recognized as an expense in the statement of operations. Any unamortized deferred contribution amount related to the capital asset is recognized in revenue in the statement of operations, provided that all restrictions have been complied with.

Financial instruments

Arm's length financial instruments are recorded at fair value at initial recognition.

Related party financial instruments quoted in an active market or those with observable inputs significant to the determination of fair value or derivative contracts are recorded at fair value at initial recognition. All other related party financial instruments are recorded at cost at initial recognition.

In subsequent periods, equities traded in an active market and derivatives are reported at fair value, with any change in fair value reported in income. All other financial instruments are reported at cost or amortized cost less impairment. Transaction costs on the acquisition, sale or issue of financial instruments are expensed for those items measured at fair value and charged to the financial instrument for those measured at amortized cost.

Financial assets are tested for impairment when indicators of impairment exist. When a significant change in the expected timing or amount of the future cash flows of the financial asset is identified, the carrying amount of the financial asset is reduced and the amount of the write-down is recognized in the Statement of Operations. A previously recognized impairment loss may be reversed to the extent of the improvement, provided it is not greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously, and the amount of the reversal is recognized in the Statement of Operations.

Contributed services

Volunteers contribute many hours per year to SSMU to ensure service delivery. Due to the difficulty of determining the fair value of contributed services, they are not recognized in the financial statements.

3. Cash and cash equivalents

The total cash balance as at May 31, 2024 includes \$473,499 (2023, \$520,559) of cash for the use of the SSMU's various internal clubs.

7. Due from (to) other funds

Any variance between actual and budgeted net results in the Operating Fund from Funding Committee, the Services, the Clubs and the Affiliate Student Associations is transferred to the Student Life Fund, after fulfilling the requirement of the Capital Expenditures Reserve Fund, at the end of the fiscal year. Excess of expenses over revenue generated in the Operating Fund shall be transferred from the CERF on an annual basis.

As at May 31, 2024, a loss of \$227,651 (2023, loss of \$1,200,174) was transferred from the Operating Fund to the Capital Expenditures Reserve Fund and an amount of \$1,385,664 (2023, \$796,133) was transferred from the Operating Fund to the Student Life Fund.

The due from (to) other funds have no specific terms of repayment, are unsecured and non-interest bearing.

11. Contingencies

In the prior year, a group of corporations and individuals instituted proceedings in the amount of \$971,000 plus interest and additional indemnity against SSMU. SSMU has contested this claim and intends to defend against it. The possible monetary outcome of this proceeding cannot be foreseen and such, no provision has been made in the financial statements.

Additionally in the prior year, a former executive instituted proceedings in the amount of \$700,500 plus interest and additional indemnity against SSMU. Subsequent to year-end, the SSMU reached a settlement agreement in the amount of \$90,000.

12. Commitments

The SSMU entered into a software licence and services agreement ending in March 2026. The installments over the next two years are the following:

13. Related party transactions

Included in General administration are administrative revenues received from SSMU Daycare Centre Inc., a daycare under control of SSMU by virtue of common board members, totalling \$6,000 (2023, \$6,000). These transactions were concluded in the normal course of business and are measured at the exchange amount, which is the amount of consideration established and agreed to by the related parties. Receivables were measured at cost, determined using their undiscounted cash flows. No difference resulted from these transactions.

14. Financial instruments

Financial risks

SSMU is exposed to various risks through its financial instruments, without being exposed to concentrations of risk. The following analysis provides a measure of SSMU's risk exposure at the statement of financial position date of May 31, 2024. There have been no substantive changes in the company's exposure to financial instrument risks, its objectives, policies and processes for managing those risks or the methods used to measure them from previous periods unless otherwise stated in this note.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. SSMU is exposed to this risk mainly in respect of accounts payable, accrued liabilities, and long-term debt.

Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk and other price risk. SSMU is mainly exposed to interest rate risk and other price risk.

Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. SSMU is exposed to interest rate risk on its fixed-interest rate financial instruments. The fixed-rate investment certificates and long-term debt subject SSMU to a fair value risk.

Other price risk

Other price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk), whether those changes are caused by factors specific to the individual financial instruments or its issuer, or factors affecting all similar financial instruments traded in the market. SSMU is exposed to other price risk through its investments in shares quoted in an active market.

15. Comparative figures

Certain figures for 2023 have been reclassified to conform to the presentation adopted in 2024.

16. Budgeted figures

All budgeted figures have been provided by management and have not been audited nor reviewed.

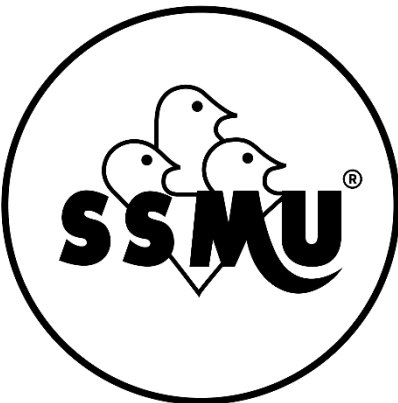

APPENDIX D

University space and/or facilities managed by the Association in accordance with Section 18.

- A. The Association is entitled to operate certain revenue-generating activities in the University Centre in accordance with terms of the Management Agreement and leases that may be entered into in accordance therewith.

Except for the SSMU Daycare in the Brown Students Services Building operated in accordance with the Lease Agreement with the SSMU Daycare:

- no space has been designated for revenue-generating activities by the Association outside of the University Center;
- the Association shall not operate nor manage, whether directly or under contract, vending machines or food counters outside the University Centre.

- B. For any space which may be designated for revenue-generating activities, the following conditions would apply:

- The Association must receive the University's prior written approval from the Deputy Provost (Student Life and Learning).
- The Association must receive the University's prior written approval from the Deputy Provost (Student Life and Learning) for changes in the use of University space for these revenue-generating activities.
- The Association shall conform to (i) all federal and provincial laws and regulations, (ii) municipal rules and regulations, (iii) its charter documents, by-laws and constitution, and (iv) all applicable University regulations and policies which apply to the use of the buildings.
- The Association shall undertake no alteration to the premises without the express consent of the University and shall affix no new signs.
- All costs related to the operation of the revenue generating activities shall be the sole responsibility of the Association.

APPENDIX E

University space and/or facilities granted to the Association in accordance with Section 18.2

- A. The Association operates from SSMU OFFICES located in Suite 1200 of the Brown Building until May 31, 2025.

Effective June 1, 2025, the SSMU OFFICES shall be located in Rooms 401 (unless alternate space is identified), 403, 404, 405, 406, 407, 408 and 409 of the University Centre. Once the Management Agreement is concluded, a lease will be entered into for these spaces, where the rent shall be fixed at \$1.00 for the duration of the Agreement.

Unless otherwise agreed in writing, the lease for space in the University Centre will automatically terminate in the event the present Agreement terminates.

- B. Any additional space allocated to the Association is granted at the discretion of the University in accordance with the Management Agreement. Such space may be re-allocated by the University at any time and at its entire discretion. Permission to use the space in any subsequent year may not be assumed. The Association shall assume all costs related to removing its operations, groups, or activities from the space.
- C. The Association must receive prior written approval from the Deputy Provost (Student Life and Learning) for any changes in the use of University space.

- A. Permission to use the McGill name, trademark, crest or shield is expressly denied.
- B. Each Group shall include the following on their website and/or in their advertisements:
"A student group of the SSMU (Students' Society of McGill University)"
- C. The Association will undertake all necessary means to correct any improper use of the McGill name, marks or reference within the shortest delay.
- D. Names are approved as listed below and are subject to the conditions set out in this Agreement.
- E. The Association shall ensure that all the Association's Groups conform to the conditions set out in this Agreement.
