Position description

The McGill University Department of Surgery, Division of General Surgery invites applications for a faculty position. This is a full-time Contract Academic Staff (CAS) appointment at the rank of Assistant or Associate Professor and does not confer eligibility for tenure.

The McGill Endocrine Surgery Group within the Division of General Surgery consists of two fellowshiptrained endocrine surgeons. As a quaternary care academic medical center, our surgeons see a high volume of complex endocrine surgical cases. We perform approximately 250 thyroidectomies, including neck dissections, 100 parathyroidectomies for primary, secondary and tertiary hyperparathyroidism, and 30 adrenalectomies each year, both open and minimally invasive.

Our clinics, which include Complex Endocrine Surgery, Endocrine Surgical Oncology, Thyroid Biopsy Clinics, Multidisciplinary Thyroid Cancer Clinic, and Multidisciplinary Adrenal Clinic, provide over 6000 outpatient visits along with over 700 new patient visits each year.

Job Duties

The successful candidate will be expected to establish and develop an academic clinical practice at the McGill University Health Center and actively participate in all clinical activities and share on-call responsibilities.

The successful candidate will also be expected to participate actively in all aspects of McGill's academic mission (i.e., research, teaching, supervision of graduate students and residents, and service on academic and administrative committees).

More specifically to the endocrine program, the successful candidate will be responsible for performing surgery, working with multidisciplinary teams, and staying abreast of advances in endocrine surgery.

McGill faculty members are expected to contribute to service activities within their units, the University, and the wider scholarly community. A commitment to equity, diversity and inclusion is also expected.

Responsibilities include:

(i) Performing surgical procedures on endocrine organs, including but not limited to thyroidectomy, parathyroidectomy, and adrenalectomy;

(ii) Diagnosing and treating endocrine disorders through comprehensive evaluation, imaging, and laboratory testing;

(iii) Collaborating with endocrinologists, radiologists, pathologists, and other health care professionals to provide integrated patient care;

(iv) Staying abreast of the latest advances in endocrine surgery and contribute to the development and implementation of best practices;

(v) Participating in interdisciplinary rounds, case conferences, and other collaborative activities (i.e., multidisciplinary clinics) to ensure the highest quality of patient care.

Qualifications and Education Requirements

Applicants must:

- Possess a medical degree, have completed general surgery training with a Royal college of Physicians and Surgeons of Canada certification or equivalent and have completed a minimum one-year fellowship;
- Be an academic general surgeon licensed or be eligible for licensure in the province of Quebec;
- Have an existing academic focus and/or track record in research is an asset;
- Candidates must demonstrate excellence in clinical care, innovation, and teaching;

Expected skills include:

(i) Proficiency in endocrine surgical techniques;

- (ii) Strong diagnostic and decision-making skills;
- (iii) Excellent communication and collaboration skills; and,
- (iv) Ability to work in a fast-paced and high-pressure environment.

(v) Bilingual language skills (French and English) are preferred, or a commitment to acquire these language skills at the level needed to practice medicine in Quebec. The successful candidate should be able to interact in English and in French with patients, families, and health care professionals.

McGill University is an English-language university where most teaching and research activities are conducted in the English language, thereby requiring English communication both verbally and in writing.
